



REQUEST FOR TOTAL DEMOLITION SERVICES

On behalf of my/ourselves, our heirs, inheritors and any successors, I/we agree to hold harmless and release from liability Team Rubicon and attached volunteers from any and all liability associated with this request. I/we specifically understand that Team Rubicon will undertake to demolish the property and is not agreeing to salvage or recover any portion of the property on my/our behalf.

[] If, in the sole judgment of Team Rubicon, it becomes unsafe, prohibited by ordinance or decree, or otherwise impractical to undertake or continue demolition operations, Team Rubicon may choose to halt or not begin operations at its discretion. I/we understand that, if operations are interrupted or halted, my property may be left in worse condition than it is in currently. I/we accept full responsibility for this and agree to hold Team Rubicon harmless for any and all outcomes of those decisions.

[] Team Rubicon and associated volunteers are performing these services by my/our personal request on a volunteer basis without recompense or financial reward. I/we agree to release from liability and forever hold harmless Team Rubicon, all individual Team Rubicon members, its Officers and Agents, all associated volunteers, and any other persons or entities who provide assistance to Team Rubicon in the performance of these services from any liability for performance, lack of performance, or negligence on the part of any party.
